4) Please describe the purpose and intent of the grant.

As one of the largest homeless service providers in Los Angeles, The People Concern's priority is providing our most vulnerable neighbors with an opportunity get off the streets and rebuild their lives. To further this goal, The People Concern is requesting funds to provide motel vouchers to be used by our E6 Outreach Team, who will engage homeless individuals in the Olympic Park neighborhood. This funding will benefit the community by providing immediate shelter to homeless individuals, building trust with clients to potentially allow further services, and stimulating the local economy.

How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

If funding is awarded, the vouchers will be used by our multidisciplinary outreach team as an essential part of their program. These vouchers are a proven part of our spectrum of comprehensive services and will benefit the public at-large in multiple ways. For every motel voucher distributed, a community resident is automatically safer and in more humane conditions. Moreover, while the vouchers are a form of immediate assistance, they also serve as an engagement tool to build trust with clients, who may choose to participate in additional homeless service programs. Finally, the vouchers also stimulate the local economy. The requested funds will make a valuable impact on the lives of our community's most vulnerable and the neighborhood as a whole.
