Sue McCullough from LANA

**Neighborhood Concerns on Road Dieting**: Sue expressed concerns over the city's plans to reduce lanes on major streets like La Brea and Olympic to accommodate more cyclists. She argues this will worsen traffic, push frustrated drivers onto residential streets, and create more dangers for pedestrians and bicyclists.

**Request for Feasibility and Impact Studies**: Sue emphasized the need for city planners and the Department of Transportation to provide detailed studies and reports on the effectiveness of these projects, including the actual usage by cyclists and the costs involved.

**Safety and Quality of Life**: She stressed that these changes do not improve quality of life, especially for families, the elderly, or those who rely on cars for transportation. Sue requested a meeting with city planners to discuss alternative solutions and address the community's safety concerns.
