Parents, Educators, Teachers & Students in Action (PESA) receives referrals from the district attorney’s office, probation department, and local schools of youth residing within the boundary of the Olympic Park Neighborhood Council that need support services. The purpose of the referrals is to address inappropriate behavior and provide these youth with support services. PESA provides these youth with mental health support, career training and educational support. These youth and their families require supportive services for the purchase of food, household items, school supplies and clothing.

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large.

PESA does not have a funding stream to adequately support the needs of these youth and their families residing within the boundaries of the Olympic Park Neighborhood Council concerning the purchase of food, household items, school supplies and clothing. These youths and their families either meet the qualifications of being homeless or are in jeopardy of being homeless. Therefore, by providing funding for this NPG request you will assist us in breaking the cycle of poverty, homelessness and criminal behavior. All our programs are designed to break the cycle of poverty, homelessness, and criminal behavior. PESA’s methodology: insert aid into every area that is a consequence or determinant of homelessness, poverty or criminal justice involvement. This serves a valuable public purpose and benefits the public at large by addressing the pipeline that leads to poverty, homelessness and criminal behavior.


